SUBJECT

The scope of the work of the temporary staff to be contracted to SARF AUA under this call is set out in the table included in the Annex.

A more detailed description of the scope of the contract, as well as the deliverables related to it, will be reflected in the contracts to be concluded between the FASU (SARF AUA) and the selected candidate.

The correct execution and control of the project deliverables will be certified by the Scientific COORDINATOR of the project.

PAY

The total fee is # 7,000.00 #€ (seven thousand euros). This amount will be subject to all legal deductions.

TIME FRAME

The total estimated duration of the contracts to be concluded between the SARF AUA and the selected staff will be up to twelve (12) months.

Contracts may be renewed or extended by decisions of the Research Committee, on the recommendation of the Scientific COORDINATOR, without limitation, until the end date of the project/programme, provided that they are within the approved budget limits of each project or programme. Contracts concluded for the needs of a project/programme that does not have a clear end date may be renewed or extended for a period not exceeding a total of five (5) years, provided that they are within the approved budget limits of the project or programme.

PLACE OF EXECUTION

As a place of execution of the project/ programme, the contractor is allowed to work at the premises and facilities of the Laboratory of Plant Pathology of the Agricultural University of Athens, located at 75 Iera Odos, 11855, Athens.

REQUIRED QUALIFICATIONS¹

¹ In case the candidate has a foreign degree and has not received recognition of said degree and/or postgraduate diploma and/or doctoral degree from DOATAP (**Hellenic National Academic Recognition and Information Center (Hellenic NARIC)**), he/she may submit a candidature file. In this case, the responsible body of the university, in order to determine whether a foreign institution or a type of foreign institution degree are recognised, is bound by the National Register of Recognised Higher Education Institutes of Foreign Countries and the **National Registry of Foreign Recognized Academic Title Types**, to which Registers foreign institutions are included by decisions of the DOATAP board. EVALUATION PROCEDURE

The applications for each position are evaluated by the following Evaluation Committee as appointed by the Research Committee of SARF AUA.

If a practical test or a test of specific knowledge is carried out, the candidates' participation will be assessed as pass or fail. Unsuccessful candidates will be placed on the disqualification list. The mark for each candidate's interview will be the average of the marks obtained by the members of the Evaluation Committee. The content of the interview, including the critical and substantive points, will be summarised in the minutes of the Evaluation Committee and the marks awarded to each candidate will be briefly explained by each member of the Evaluation Committee.

The Scientific COORDINATOR, who acts as the Chairperson of the Evaluation Committee, is appointed as a regular member of the Evaluation Committee. The Committee is appointed by a decision of the Research Committee of SARF AUA. The term of office of the Committee is equal to the duration of the project if the project has a clear end date, otherwise the term of office is annual. Members of the Committee may not be spouses or partners nor have blood or marriage relations up to the third degree of consanguinity with any candidate. If a member of the Commission is prevented from exercising its functions under the previous subparagraph, it shall notify the other members of the Commission in writing, requesting that its alternate member replace it.

The recommendation of the Committee is forwarded to the Research Committee of SARF AUA.

ANNOUNCEMENT OF RESULTS

After their approval by the Research Committee of SARF AUA, the preliminary results of the evaluation are posted on the website of the SARF AUA web department, www.elke.aua.gr. After the expiry of the deadline for lodging an objection according to par. 2 of article 245 of Law 4957/2022 (Government Gazette 141/A/21.08.2022), the results are automatically final.

LODGING OF OBJECTIONS

Candidates who have applied for a post under this Call are entitled to:

- A.** lodging an objection against their ranking within 5 calendar days from the day after the results are posted, by submitting a written request to the FASU SARF AUA.
- B.** access to the data of the individual application file and the evaluation sheets of the other candidates, following their written request to the FASU SARF AUA within 5 calendar days after the results are published.
- C.** no objection is allowed on grounds relating to the interview or knowledge test and the skills and work efficiency test.

Candidates who intend to exercise their legitimate right regarding the selection procedure and the results may, on written request, ask for access to the files and supporting documents of other candidates. The documents submitted by the candidates constitute personal data of the candidates under Article 4 of the General Data Protection Regulation 2016/679. At the same time, the same documents constitute administrative documents under Article 5 par. 1 of the Code of Administrative Procedure, if and insofar as they have been taken into account when forming the relevant judgment. The right of access may be satisfied under the terms of the legislation on personal data and Article 5 of the Code of Administrative Procedure and in accordance with the conditions consistently accepted by the Authority for the Protection of Personal Data Protection (ενδ. ΑΠΔΠΧ 28/2018). Before the data are provided to applicants, it is possible to inform the persons to whom the data refer. In any case, applicants are informed through this Call that the documents and supporting documents they submit may be granted to their co-applicants without being informed individually before such grant. This information, here, takes the form of prior notification of this possibility.

Requests for objections must be submitted in one of the following ways: in person, by an authorised proxy, by post, by courier. The date of submission of the application is the date on which it is deposited at the Protocol Secretariat of SAFU SARF AUA. If the closing date of the above deadline is not a working day, the deadline will be postponed to the next working day. Late applications will not be considered and will not be examined.

If a member of the Commission is prevented from exercising its functions, it shall notify the other members of the Commission and the institution which appointed it in writing, requesting that its alternate member replace it. After the decision of the Objections Committee, the evaluation results become final.

The results (provisional and final) are posted on the SARF AUA website and in the "DIAVGIA" (TRANSPARENCY INITIATIVE) programme.

The Objections Committee examines the objections submitted and makes a reasoned recommendation to the Research Committee to accept or reject them. By decision of the selection board, the final result lists are validated and the decision on each objection is communicated to the candidate. If the Research Committee finds an infringement of the law or of the Funding Guidelines or any other regulatory act, either on its own initiative or following an objection, it may decide to repeat the call in whole or in part. In the case of omissions or defects that need to be completed or corrected, the Research Committee may, instead of reopening the notice, complete or correct the omissions or defects, if this is possible.

OTHER TERMS

1. The following documents are taken into account as evidence of the subject matter and duration of the experience:

A certificate from the insurance institution confirming the duration of the insurance (for candidates whose experience is in the private sector) or a certificate from the relevant public body (for candidates whose experience is in the public sector).

If the certificate from the insurance institution does not indicate the specific experience required under this Call for applications, a contract or a service provision card covering the duration of the specific experience is required.

For proof of a foreign language, it is sufficient to submit a copy of the relevant language certificate.

The certification of computer literacy is proved on the basis of the provisions of Article 27 par. 6 of Decree 50/2001 "Determination of qualifications for appointment to positions in public sector bodies as in force" (Government Gazette A 39/5.3.2001, Government Gazette A 24/30.01.2013 and Government Gazette A 63/9.3.2005).
5. In the event of a tie between candidates, the candidate with the highest degree will be ranked first and, in the event of a tie, the candidate with the highest postgraduate degree will be ranked first.
